ATTENDED FUNERAL (funeral director's charges only).

UNATTENDED FUNERAL

This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

² In England, Wales and Northern Ireland, you will usually need to pay for doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

Final invoices to be settled within 30 days of the final invoice. Tovey Bros reserves the right to charge 1.5% above the Lloyds Bank base lending rate for any overdue amounts. 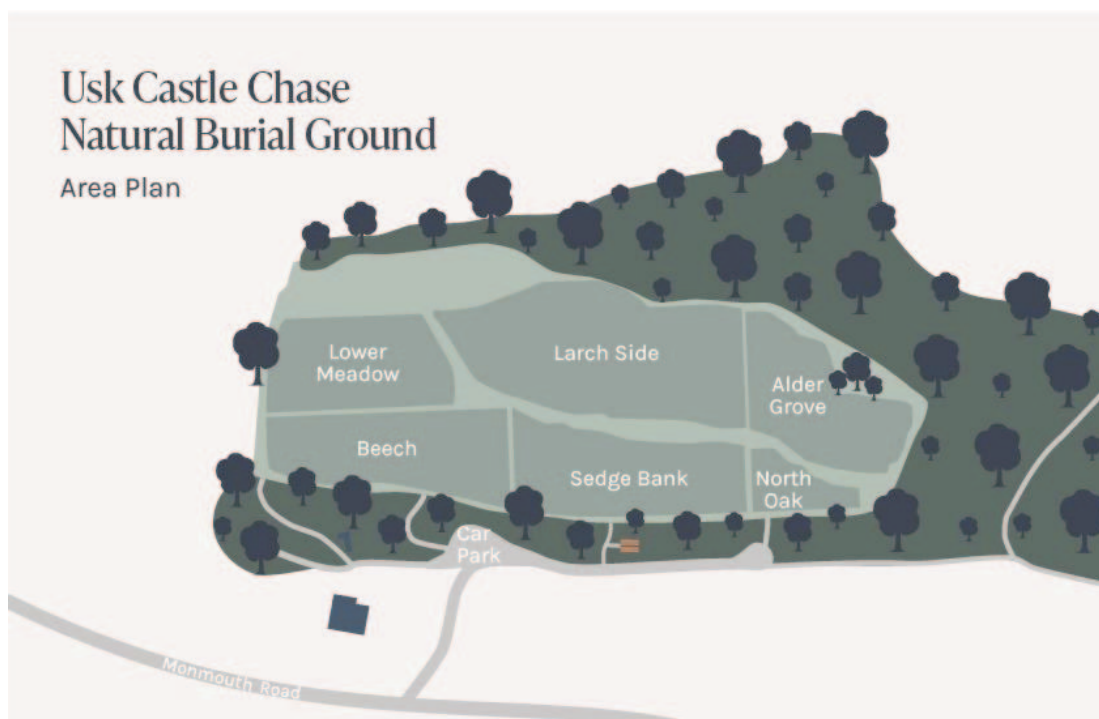

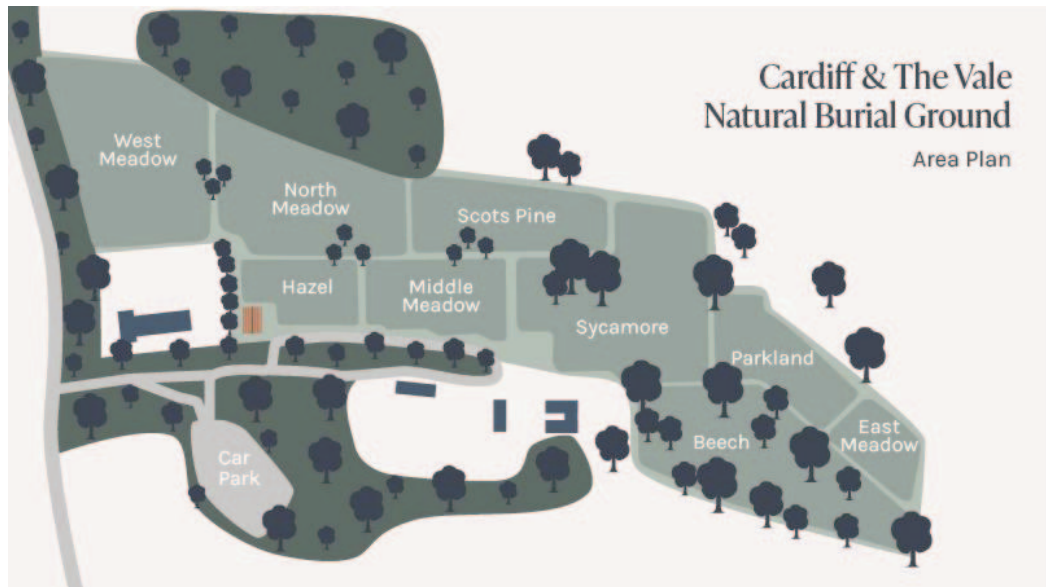

No fee shall be payable in respect of the burial of a **still-born infant or child under the age of 18**, or in connection therewith, for the services rendered by the Incumbent or other Minister officiating at an interment or, in connection therewith, for registration of burial.

The **Ministry Fee** covers attendance by the officiating minister at i) a funeral service, or ii) a funeral service followed by burial, or iii) a funeral service followed by a cremation and the subsequent interment of cremated remains. This applies whether the attendance is at a Church in Wales church or elsewhere. The Ministry Fee also includes the signing of the Green Form by the officiating minister. Additional charges for travel costs outside the parish or ministry area may also be levied by the officiating minister.

The **Church Fee** covers use of the church for a funeral or memorial service. Additional charges can be made for organist, choir, sexton and the reasonable cost of additional heating.

The **Burial Fee** is for the burial of a body or cremated remains in the allocated grave or cremated remains plot. An additional charge, set locally, will be made for grave digging. The fee is also applicable to a burial or interment in an existing grave or plot.

The **Memorial Fee** is for the grant of the right to erect a monument on the grave in accordance with the Churchyard Regulations. There will be no reduction for a total replacement of the memorial and a partial replacement will be charged pro-rata. The maintenance of the monument remains the responsibility of the family that erected it.

EXTRAS

The fees shown in the table do not include charges for heating, the services of a vergier, music (e.g. organist, choir), bells, and flowers, which are fixed by the Parochial Church Council. In the case of a marriage service or a funeral service in church, any costs and expenses incurred in respect of routine administration (including arranging dates and times and the making of entries in registers), making the church available and lighting it are included in the fee prescribed as payable to the Parochial Church Council.

Statutory fees are only prescribed for matters in respect of which parishioners have a legal right. Not all services come into this category, for example funerals where there is a period of more than 48 hours between the funeral service and the cremation and between the cremation and the disposal of ashes. This also applies to special services such as memorial services and services of blessing and dedication following a civil marriage. The Archbishops' Council recommends that, where a memorial service is on a similar scale to a funeral service, or a service of blessing and dedication following a civil marriage or a renewal of marriage vows is on a scale equivalent to a wedding service, the PCC fee should be based on the statutory fee for the service, with the PCC receiving the equivalent of the combined DBF and PCC fee.

NOTES:

A1. Certificates of Baptism

The fee for a certificate issued at the time of baptism is for a certified copy of the entry in the register book of baptisms giving the particulars required in Form No 1 in Schedule 1 to the Parochial Registers and Records Measure 1978. The fees payable for a certified copy of the full entry issued at any other time are the fees prescribed for searching registers of baptisms and burials and, if applicable, for each additional copy of an entry in such a register.

A2. Searches in Church Registers

The search fee relates to a particular search where the approximate date of the baptism or marriage is known. The fee for a more general search of a church register is negotiable.

A3. Costs and Expenses

In the case of a marriage service in church, any costs and expenses incurred in respect of routine administration (including arranging dates and times and the making of entries in registers), making the church available and lighting it are included in the fee prescribed as payable to the parochial church council.

In order to ensure their safe return we request that they be collected prior to the day of the funeral.

8. DSS Claim

The Client shall inform the Firm of any DSS Claim or their intention to make such a claim in respect of the Service.

9. Joint and Several Liability

Where the Client comprises one or more persons then their liability under the Terms and Conditions shall be on a joint and several basis.

10. Embalming

The Firm employs qualified embalming staff and it is the Firm's policy to provide whatever level of hygienic treatment is necessary in its professional judgement. In many cases, embalming is undertaken and in these circumstances, no additional charge is made.

11. Family Bearers

It is the responsibility of the family to ensure that bearers arranged by themselves are physically able to perform the task and that they be aware of and accept the risks involved. Our staff can provide some guidance, but cannot be held liable for any injury resulting from bearing, which is undertaken entirely at the individual's own risk.
